I hereby solemnly and sincerely affirm:

1. That the statements made and information furnished in my son's / daughter's / ward's application and also in all the enclosures there to submitted by him / her are true. Should it however, be found that any information furnished there in is untrue in material particulars, I realise that I am liable to criminal prosecution and I also agree to the forfeiture of the seat in the institution.
2. That my son / daughter /ward would confirm strictly to all the rules and regulations in force now or which may be introduced in the institution hereafter and that I realise that breach of discipline and rules on my son's/daughter's/ ward's part would entail summarily forfeiture of his /her seat in the institution.
