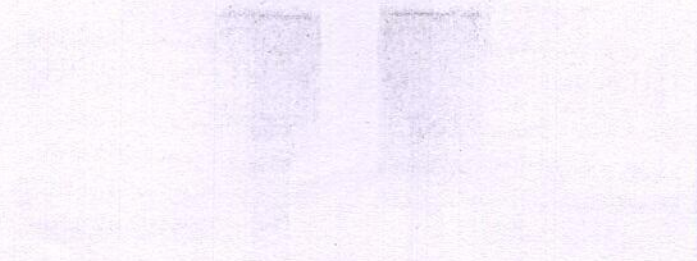

3. Training Period

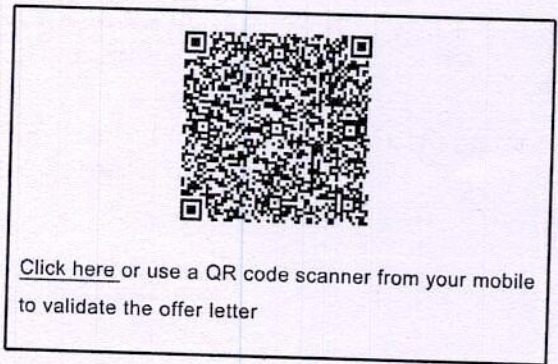

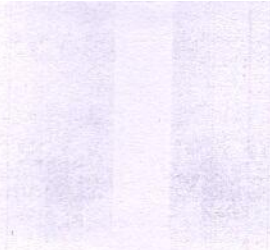

- (c) Corporate strategies and other confidential and proprietary material and information, which could cause competitive harm to TCS if disclosed,

10. General

(a) The provisions hereof shall be interpreted, determined and enforced in accordance with the laws of India.




